

INFORMATION FOR AUTHORS

IEEE TRANSACTIONS ON ELECTRON DEVICES is published monthly. It comprises original and significant contributions relating to the theory, design, performance and reliability of electron devices, including optoelectronic devices, nanoscale devices, solid-state devices, integrated electronic devices, energy sources, power devices, displays, sensors, electro-mechanical devices, quantum devices and electron tubes. Tutorial and review papers on these subjects are also published and occasional special issues appear to present a collection of papers which treat particular areas in more depth and breadth. On-line access is included with EDS membership at www.ieee.org/ieeexplore.

Regular papers normally have a length of six published pages (**To estimate the length of a manuscript, assume 900 words per published page and 1/6 page per figure and indicate the estimated number of pages on the top right hand corner of the cover page**). Manuscripts longer than six pages will be considered, but have a proportionately lower probability of acceptance. Hence, author(s) are encouraged to provide the most value per page by presenting their work as compactly as possible without being telegraphic or incomplete. Each paper must include an abstract of not more than 200 words. Additionally, all papers should include keywords (indexing terms) chosen from the IEEE keyword list. This list can be accessed by sending a request to keywords@ieee.org. Regular papers are sent to at least two experts on the topic for comments, which are then used by the editorial board in selecting papers for publication.

Briefs are reports of preliminary results and short reports on completed work that are of current interest to many workers in the field. The length must be 2000 words or less with each figure counted as 150 words and each equation equal to 40 words. A 50-word abstract is requested.

Correspondence includes comments on material previously published in the TRANSACTIONS, suggestions for new work, and errata. The format and length restrictions are the same as given above for Briefs.

Manuscripts: One original, **single-sided, single-column, DOUBLE SPACED**, and three copies (**double-sided, DOUBLE SPACED**, is encouraged to conserve natural resources and reduce mailing costs) complete with all illustrations, should be submitted to the IEEE/EDS Publications Office (see inside front cover). All materials, including drawings and photographs, should be no larger than 23 x 28 cm. (8 1/2 x 11 in). Larger sizes complicate handling. The style for references, abbreviations, etc., can be determined from previous issues of this TRANSACTIONS. Prospective authors are encouraged to read it and follow its recommendations on the organization of their paper. Author(s) are warned specifically that the use of computer notations, such as 1E-10, [Hertz]**1/2, etc.—either in text or in figures—is not acceptable. In the letter accompanying the manuscript, the author should indicate which category in the Table of Contents would be most suitable for the paper. These categories are (alphabetically): 1) Compound Semiconductor Devices; 2) Materials, Processing, Packaging; 3) Molecular Electronics/Quantum Devices; 4) Nanoelectronics; 5) Optoelectronic, Displays, Imaging; 6) Reliability; 7) Sensors and Actuators; 8) Silicon Devices; 9) Solid-State Device Phenomena; 10) Solid-State Power and High-Voltage Devices; 11) Superconductive Devices; 12) Vacuum Electron Devices.

Submission of a manuscript amounts to assurance that it has not been copyrighted, published, or accepted for publication elsewhere, that it is not currently being considered for publication elsewhere, and that it will not be submitted elsewhere while under consideration by this TRANSACTIONS. In cases where there is even a potential for significant overlap between the manuscript and previous work, it is the responsibility of the author(s) to provide references to pertinent previous publication and copies/preprints of manuscripts undergoing pre-publication review elsewhere. **Failing to do so will compromise the peer review process and render such papers ineligible for publication.** All materials not accepted will be returned.

The affiliation and address of the author(s) should be indicated on the title page of all submissions. Also, please highlight the **telephone, fax, mailing address, and email** of the corresponding author. Regular papers should be accompanied with a brief biography and a black/white glossy photograph of the author(s), as well as an IEEE copyright transfer form (see below). The deadline for submitting bio(s) and photo(s) is no later than with the return of the final version of the manuscript.

Copyright: It is the policy of the IEEE to own the copyright to the technical contributions it publishes on behalf of the interests of the IEEE, its authors, and their

employers, and to facilitate the appropriate reuse of this material by others. To comply with the U.S. Copyright Law, authors are required to sign an IEEE copyright transfer form before publication. This form, a copy of which appears in the January TRANSACTIONS, and on the web at <http://www.ieee.org/about/documentation/copyright/>, returns to authors and their employers the full rights to reuse their material for their own purposes. Authors must submit a signed copy of this form with their manuscripts at the time of initial submission.

References, figure captions, and list of tables should be started on a separate sheet and must be double-spaced. Do not include captions on the illustrations themselves, since captions are set in type separately. Figure captions should be sufficiently clear so that the figures can be understood without detailed reference to the accompanying text. Axes and graphs should have self-explanatory labels, not just symbols (e.g., Electric Field rather than E).

Illustrations: Original illustrations should be submitted along with the manuscript. The originals will be returned if requested on galley proof. All line drawings (graphs, charts, diagrams, etc.) should be prepared on a white background in black ink. Photostat copies are acceptable but only if exceptionally clear, with high contrast, preferably on glossy paper. Lettering should be done by template, be large enough (it may even appear too large) to be legible when reduced to a one-column width.

Photographs should be used sparingly. A good line drawing of an apparatus is usually more informative than a photograph. Photographs of oscilloscope traces should be of high contrast, without spurious marks due to halation or unblanked traces. All photographs must be glossy.

N.B. Previously published illustrations (figures, graphs, tables, drawings, etc.) must be so indicated by the line "Reprinted from (name of author, title of paper, journal or source, vol., page no., and date)" below the figure caption. It is the author's responsibility to secure permission from the previous publisher to reprint the material. To avoid delay, please have the permission sent directly to the EDS Publications office.

Page Numbers: Number all pages of text, including illustrations (which should be grouped at the end), in a single series to avoid losses. Figures should be identified with the figure number and author's name on the back: use a soft pencil when identifying photographs.

Page Charges: After a manuscript has been accepted for publication, the author's institution will be asked to pay a charge of \$110 per printed page to cover part of the cost of publishing. Page charges for this TRANSACTIONS, like those for journals of other professional societies, are not obligatory, nor is their payment a requisite for publication. The author will receive 100 free reprints without covers if the charge is honored. Detailed Instructions will accompany the page proofs.

Submission on Electronic Media: Authors are encouraged to submit an electronic version of the text portion of their manuscript **along with the accepted final paper copy of their work**. (Earlier electronic versions will be discarded.) The complete guidelines for the electronic format can be found at <http://www.ieee.org/organizations/pubs/transactions/information.htm>.

A brief summary is provided here for quick reference:

- 1) The operating system and word processing software used, must be noted on your disk or tape. In the case of UNIX media, method of extraction (i.e., tar, bar, dump) should be noted.
- 2) Final hard copy must match disk/tape EXACTLY.
- 3) Label disk/tape with file name(s) relating to the manuscript.
- 4) No program files should be included on disk/tape.
- 5) Include a flat ASCII version on the disk with the word-processed version, if possible.

Preferred Formats: \TeX and \LaTeX top the list of preferences. An IEEE \LaTeX style-file and IEEEtrans.sty, are available online at <http://www.ieee.org/organizations/pubs/transactions/stylesheets.htm>. Please include all macros (\def) that are required to produce your document. Note, IEEE TRANSACTIONS style dictates a 21-pica (3.5-inch) column width. When mathematical phrases are produced with this in mind, they are apt to appear more aesthetically pleasing in the final version.

Acceptable Media: Any IBM-PC (or 100% compatible) disk format: 5.25"/360k/1.2Mb-3.5"/720k/1.44Mb (DS/DD, DS/HD, DS/QD etc.), Macintosh disk format (low and high density), 0.25" magnetic tape cartridges (UNIX: tar, bar, dump), 3.5" floppy disk (UNIX workstations: tar, bar, dump), 8 mm tape cartridge (UNIX: tar, bar, dump).
