1. What is a Creative Commons Attribution License (CC BY)?

CC BY is an open access publishing license that allows authors to retain ownership of the copyright for their work while granting all users permission to publish and distribute the work. Authors should visit the [Creative Commons web page](#) to understand the terms of the CC BY, which is nonexclusive, applies to all potential users, and grants users rights to distribute and adapt the work without obtaining explicit permission from the author. The CC BY is the only Creative Commons license supported by IEEE at this time, although IEEE continually reviews OA publishing trends as they affect authors.

2. Who is entitled to use the CC BY license with an IEEE article?

Any author who pays an article processing charge (APC) for open access publishing status will be entitled to use the CC BY license.

3. What are the Terms & Conditions of IEEE Authors' Use of the Creative Commons

Attribution License (CC BY)?

Authors submitting a manuscript who opt for a CC BY license are required to accept the [Terms & Conditions of IEEE](#) in order for their paper to be published and posted in Xplore. Authors who choose to submit under a CC BY license will be subject to the publishing policies and procedures of the IEEE. For example, authors must:

- warrant that their papers meet the provisions of the IEEE PSPB Operations Manual covering originality, authorship, and author responsibilities;
- further warrant that, to the extent their papers incorporate text passages, figures, data or other material from the works of others, they have obtained all necessary third-party permissions;
- consent to having their work submitted to a plagiarism detection tool and to be bound by IEEE policies concerning plagiarism and author misconduct.

4. What is the difference between submitting a manuscript under a CC BY license and the IEEE Open Access Publishing Agreement (OAPA)?

A CC BY license allows authors to retain copyright in the work, but also carries very broad rights for end users. For instance, an end user may freely reuse the work provided they always credit the original author. The end user does not have to obtain permission from the author to reuse the work, even for commercial purposes or to create derivative works. The OAPA asks authors to transfer copyright to IEEE, thereby authorizing IEEE to protect the work against copyright infringement or plagiarism. Authors' papers are openly accessible to all users in IEEE Xplore, and authors may post the final, published version of their papers on their own web sites. In any case, authors who choose to submit a manuscript under either a CC BY license or an IEEE OA Publishing Agreement should be confident that their OA choice will in no way influence the editorial decision on their submission.

5. Can authors choose the OAPA if their work was funded by an agency that requires a Creative Commons Attribution license?

Authors are responsible for determining their funding agencies' requirements before selecting an OA license. Some funding agencies require their research authors to use specific publication licenses in place of copyright transfer if their grants are used to pay article processing charges (APCs). Two such funding agencies are the **Wellcome Trust** and the **Research Councils of the United Kingdom (RCUK)**, both of which require authors to use a CC BY license. Should an author select the wrong OA option, he or she should contact the IEEE Intellectual Property Rights Office at copyrights@ieee.org. Authors are encouraged to review carefully these matters with the appropriate entities within their own institutions to ensure that the content is intended to be openly and freely available for reuse by all third parties.

6. What steps will authors need to take in order to submit a manuscript to IEEE under a CC BY license?

Authors who want to submit their manuscripts under a CC BY license, or whose research has been supported by any funding agency and who are now required to submit their

manuscripts under a CC BY license, should complete the electronic IEEE Copyright Form (eCF), and select the CC BY license. If authors accidentally select another publishing option, or they were unable to complete the eCF, they should provide a letter or email to the editorial staff or the IEEE Intellectual Property Rights Office at copyrights@ieee.org, in which letter they should clearly state their interest in submitting their manuscript under a CC BY license. The letter should also provide basic information about the manuscript (e.g., author names, article title and IEEE publication title to which the manuscript is being submitted). Authors will receive an acceptance letter indicating that the CC BY license has been approved.

7. Will authors be allowed to provide the published versions of their articles to their funding agencies?

Under a CC BY license, authors are allowed to distribute the published versions of their OA articles however they choose, including to their funding agencies or institutional repositories.

8. How will readers/users know that an article has been published under a CC BY license?

Instead of the traditional IEEE copyright notice at the bottom of the first page of the published article, readers will see an explicit statement indicating the OA status of the article, such as “This work is licensed under a Creative Commons Attribution 3.0 Unported License.” This wording may also be accompanied by a Creative Commons graphic indicating the reuse rights under this license.
